



FY25-FY27 CAS Webinar Subscription Prospectus

The CAS is updating our pricing structure for webinar subscriptions to align more closely with industry standards. In FY25 (October 2024 – September 2025), we will phase out the unlimited webinar subscription option and introduce a new tiered system, offering different pricing options based on company size.

This new system will also enhance the management of individual company codes, ensuring they are not shared with external parties. The unlimited webinar subscription will remain available for one more year. However, those who transition early to the new tiered system will benefit from discounted prices for FY26 (October 2025 – September 2026).

Please review the table below to find the plan that best suits your needs over the next three years.

***Seats:** Please note that with the seat plan, you will have a pool of seats spread across the 24 webinars in the fiscal year. One registration at one webinar will reduce the pool of seats by one.

Regardless of your plan, every company will receive unlimited seats from October-December 2024.

Beginning in early 2025, the account holder for each subscription will receive an email the day after each webinar to let them know who signed up for the webinar and how many seats they have left in their plan.

Account holders are responsible for policing their code. Their code may be shared with any individual regardless of whether they belong to the parent organization. Please note that each registration will count as one seat. Registrants may choose to cancel their registration, which will add their seat back into the pool. This new structure incentivizes registrants to attend the CAS webinars or cancel their registration to allow other registrants to join.

Seat Expiration: Seats must be used within the FY. Extra seats do not carry over.

Out of Seats: Account Holders may purchase extra seats before the end of the year. These extra seats will not carry over.
