Achievements in 2023

Actuarial Career Prep Webinar Series

AS International organized two webinars on the 9th and 20th of March 2024 to help participants gain the skills needed for a successful actuarial career. The first webinar was on CAS exam preparation in which ARECA members shared their study habits and personal journeys regarding the CAS exam pathway. The second webinar by Ronald Kozlowski helped participants understand the concept of actuarial judgement by explaining Actuarial Standards of Practice (ASOPs), sensitivity analysis, checking one's work, research and critical thinking, as well as mentorship, ethics and communication.





Virtual Welcome Session for New Members

RECA joined hands with Asia Working Group and the CAS International team to welcome the CAS new members in Asia virtually in May 2024. CAS has a close and active member network in Asia. The session serves as an avenue to help new members connect with each other and existing members in Asia. The event also provides a

ARECA Scholarship

he ARECA Scholarship is in its 6th year, with this year's scholarship competition being a case study sponsored by Peak Re.

CAS VIP Visits in Asia

oosevelt Mosley (CAS immediate past president), Kendra Felisky (CAS past VP – International) and Ron Kozlowski (CAS Asia Ambassador) visited Malaysia, Vietnam and India to meet with local CAS members, regulators, employers, university faculty and students to not only learn about the general insurance land-scape in Asia, but to also impart knowledge regarding the CAS educational pathway.

Malaysia

On 10th December 2023, Mosley and Kozlowski attended a dinner with representatives from Actuarial Society Malaysia (ASM) to discuss the Malaysian insurance industry and the ongoing development of actuarial practices within the market. This gathering provided an invaluable opportunity to gain deeper insights into the industry, and there was a shared enthusiasm about encouraging more actuarial professionals to consider pursuing the CAS exam pathway.

On 11th and 12th of December 2023, the ASM-CAS joint seminar was held at the Hilton Kuala Lumpur. CAS provided several sessions:

- Welcome remarks by Mosley
- A talk on Driver Safety Features by Mosley
- CAS Capability Model by Mosley
- Developing Actuarial Judgement for P&C Actuaries by Kozlowski

There were other sessions provided by ASM, e.g., digital insurance in Malaysia, earthquakes in Malaysia and a panel discussion on electric vehicles.

To conclude the first day of the event, ASM hosted a dinner at Hilton Kuala Lumpur, providing members with an excellent opportunity to engage in meaningful networking and build valuable connections.

At the end of the second day of the ASM-CAS joint seminar, CAS hosted drinks for Malaysian members at the Aviary Bar, Hilton Kuala Lumpur. Mosley and Kozlowski received feedback that employers are seeing less students with CAS exams, potentially related to the Institute and Faculty of Actuaries (IFoA) giving exam credits for university courses. At the time, Mosley mentioned that International Exam Waivers were in progress.

After the ASM-CAS joint seminar, Mosley and Kozlowski visited University Tunku Abdul Rahman (UTAR) and Asia Pacific University (APU) the next day. For both universities, it was evident that there was a stronger relationship with the IFoA and

Society of Actuaries (SOA) at that time, as the CAS was not mentioned on the website or in the program brochures. However, the visit proved to be very productive. Both the university and CAS representatives agreed on the importance of increasing the visibility of CAS on the university websites or program, recognizing the value it offers students interested in the property and casualty path.

The following day, Mosley and Kozlowski had a session with Bank Negara Malaysia (Central Bank of Malaysia). A group of actuarial analysts presented on the liberalization of motor and fire insurance in Malaysia and on climate risk stress testing. The eventful day ended with a dinner with University of Malaya faculty and students. Among topics discussed were general insurance, exam waivers as well as balancing work, life and studying.

Mosley and Kozlowski also met with Heriot-Watt University faculty. Students can gain up to six IFoA exemptions from the university, hence the reason students are more inclined to take the IFoA pathway. In general, universities' actuarial sites lack CAS details, especially an introduction to the CAS exam pathway and exam waivers. Universities also need help with general insurance con-

tent and can work with the CAS/ ASM on exposing students to both traditional and non-traditional general insurance actuarial careers to improve student employment.

Vietnam

Kozlowski followed up the Malaysia trip with a visit to Hanoi, meeting with actuarial managers from local insurance companies, representatives of the Insurance Association of Vietnam (IAV) and faculty of the National Economics University (NEU). Discussions touched on providing a bursary for students taking CAS exams and improving the university's coursework to adequately prepare students for CAS exams. NEU students are actively taking CAS exams after a successful visit last year.

India

In February 2024, CAS past VP – International, Kendra Felisky, and CAS Asia Ambassador, Ron Kozlowski, toured India meeting a variety of actuarial employers, actuarial exam takers and university students. They had 15 different meetings across three locations: Delhi/ Gurgaon, Mumbai and Bengaluru where they provided CAS updates, shared subject matter expertise, and learned more about the value of the CAS credentials in the Indian market.

The visit included a National Level Open Seminar centred around "Navigating the Actuarial Career Path, the CAS Way: Insights for Students" hosted by the SSSIHL Centre of Excellence for Actuarial Data Science. Felisky and Kozlowski shared invaluable wisdom on the CAS Career Path, Actuarial Judgement, Actuaries' Code of Conduct, and Where Actuaries Get in Trouble. Following the seminar, Felisky and
