




How mobile apps enable UBI programs



Technical features to support data collection

- Auto-start (automatic trip detection)
- Driver ID algorithm (identify who is actually driving)
- Wi-Fi only data upload (no drain on driver's data plan)
- Manual trip tagging

Phone use, driver identity Vehicle position, acceleration, braking, cornering, speed, mileage

Vehicle diagnostics, vehicle identity (VIN)





How smartphone UBI programs are evolving

- Battery conservation
 - Lower sampling rates
 - Bluetooth beacons to reduce battery drain and record a higher proportion of trips
- Algorithms to identify trips taken outside the insured vehicle
- Automated crash detection (ACD)
- Scoring based on distracted driving (e.g., phone use, grooming)
- Gamification (rewards, competing with friends)
