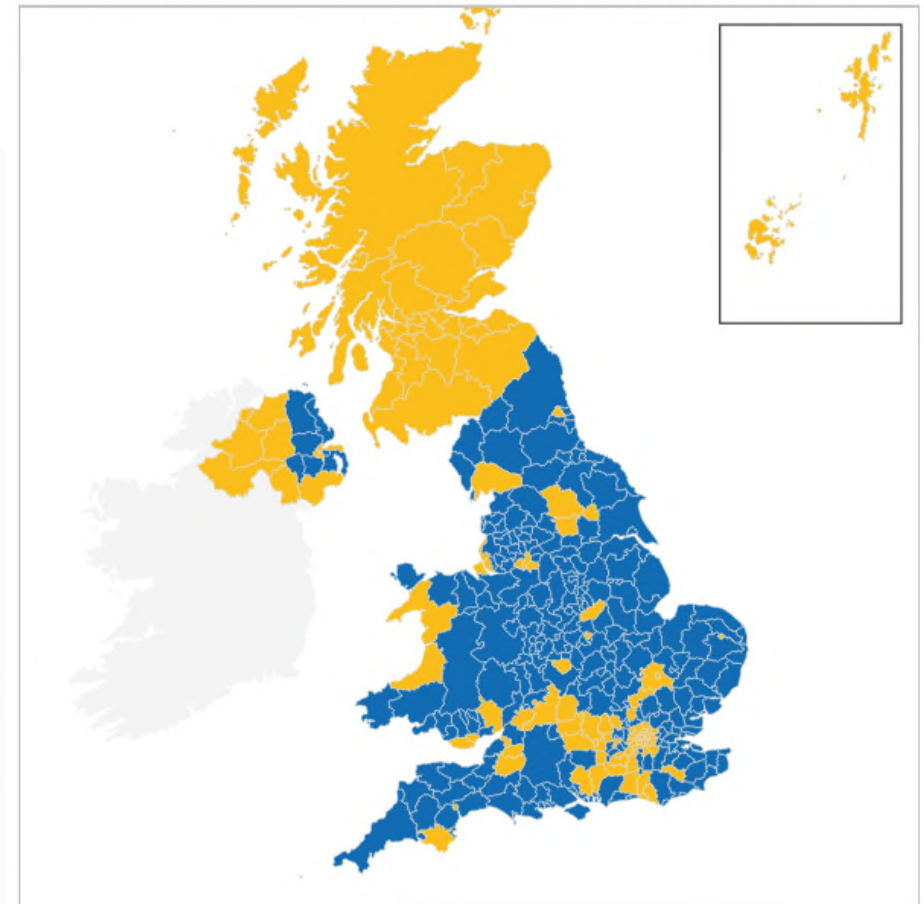
How did the UK vote?

Key: ■ Majority leave ■ Majority remain ■ Tie ■ Undeclared



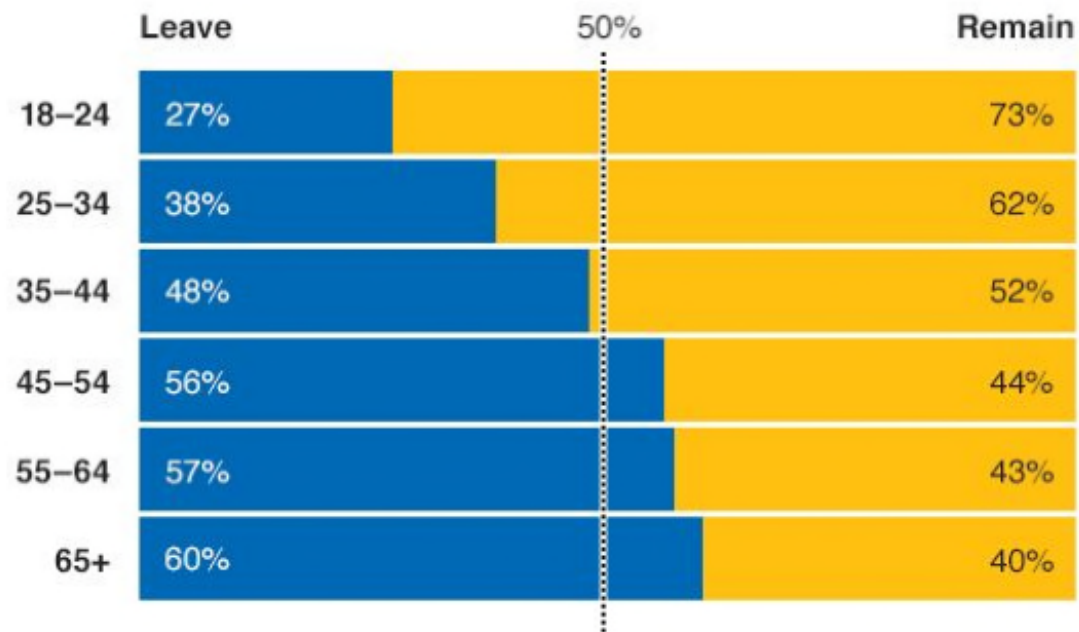

How different age groups voted

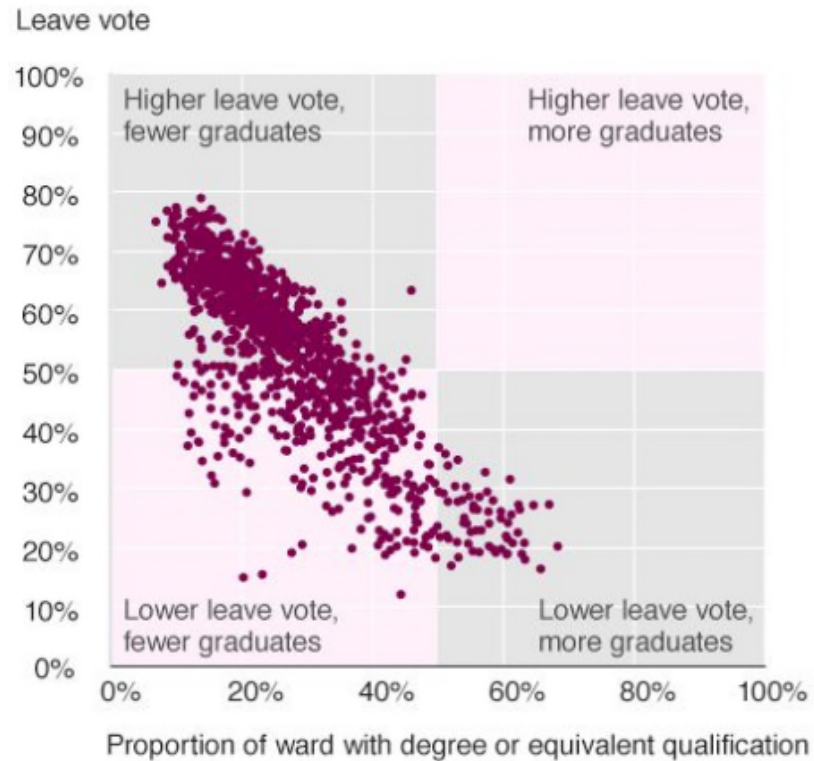

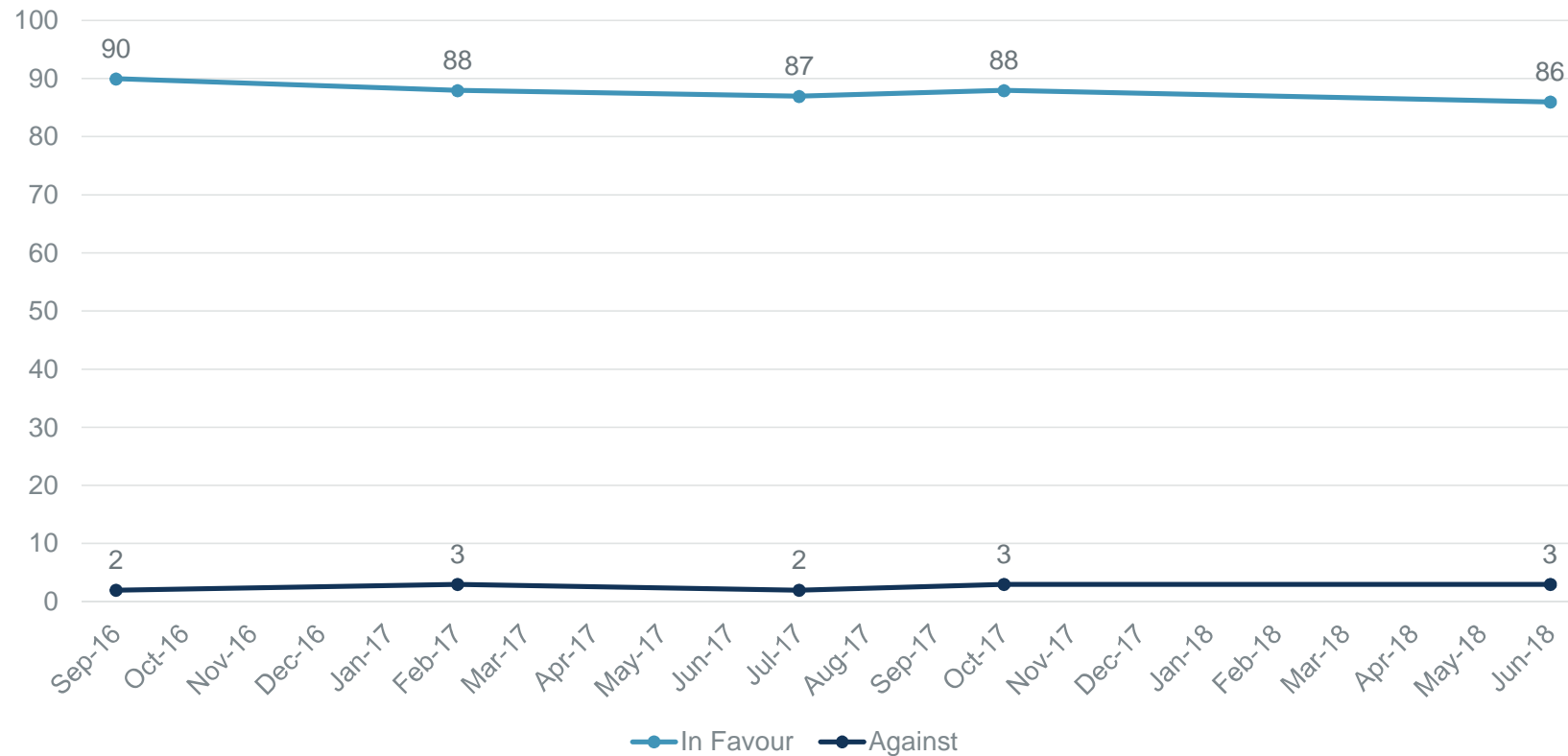

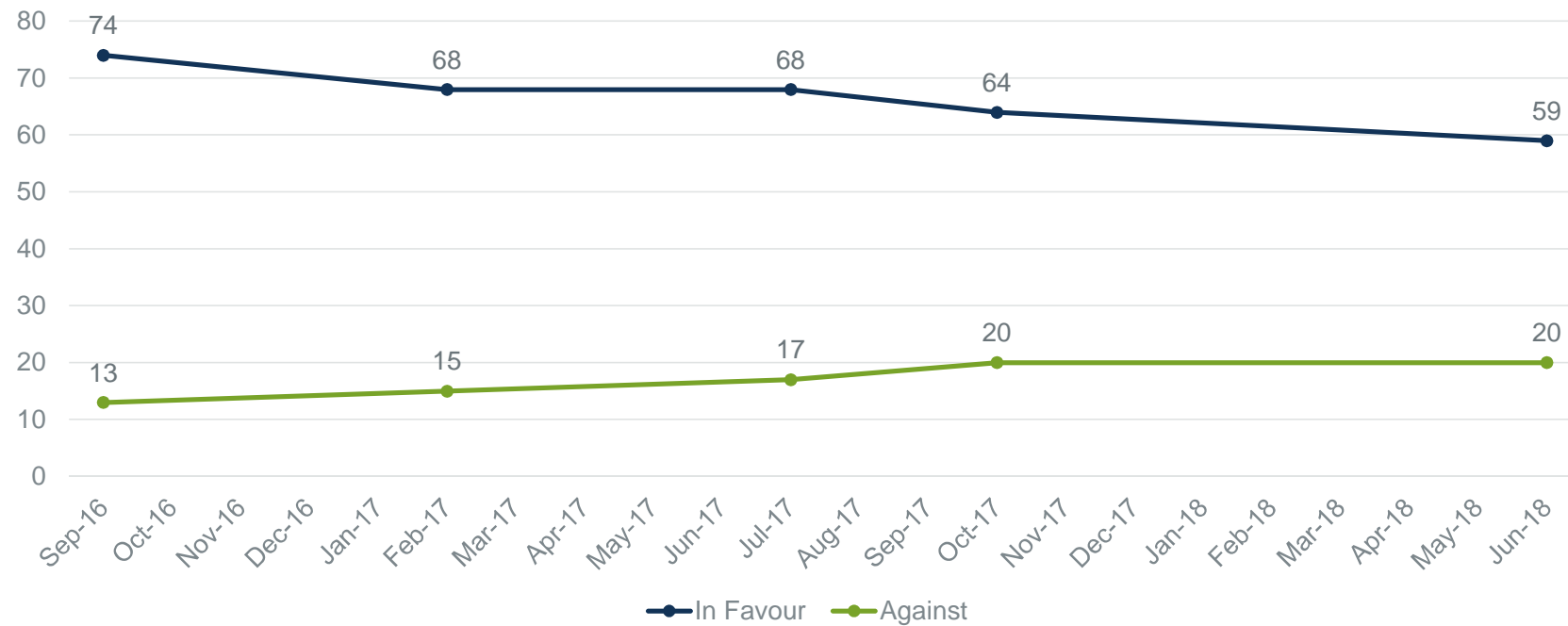

Attitudes towards Free Trade with the EU



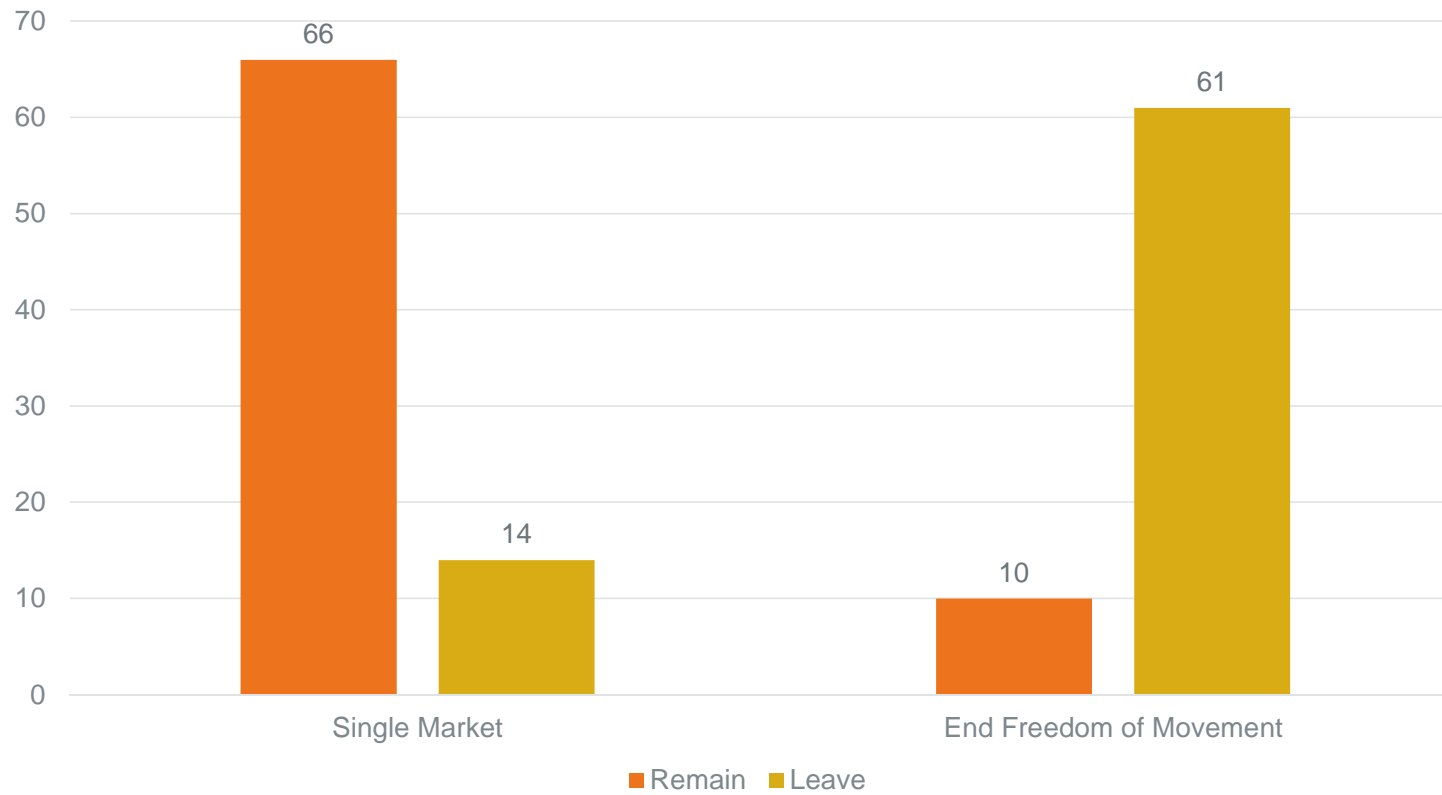

Attitudes towards treating EU Migrants like non-EU Migrants



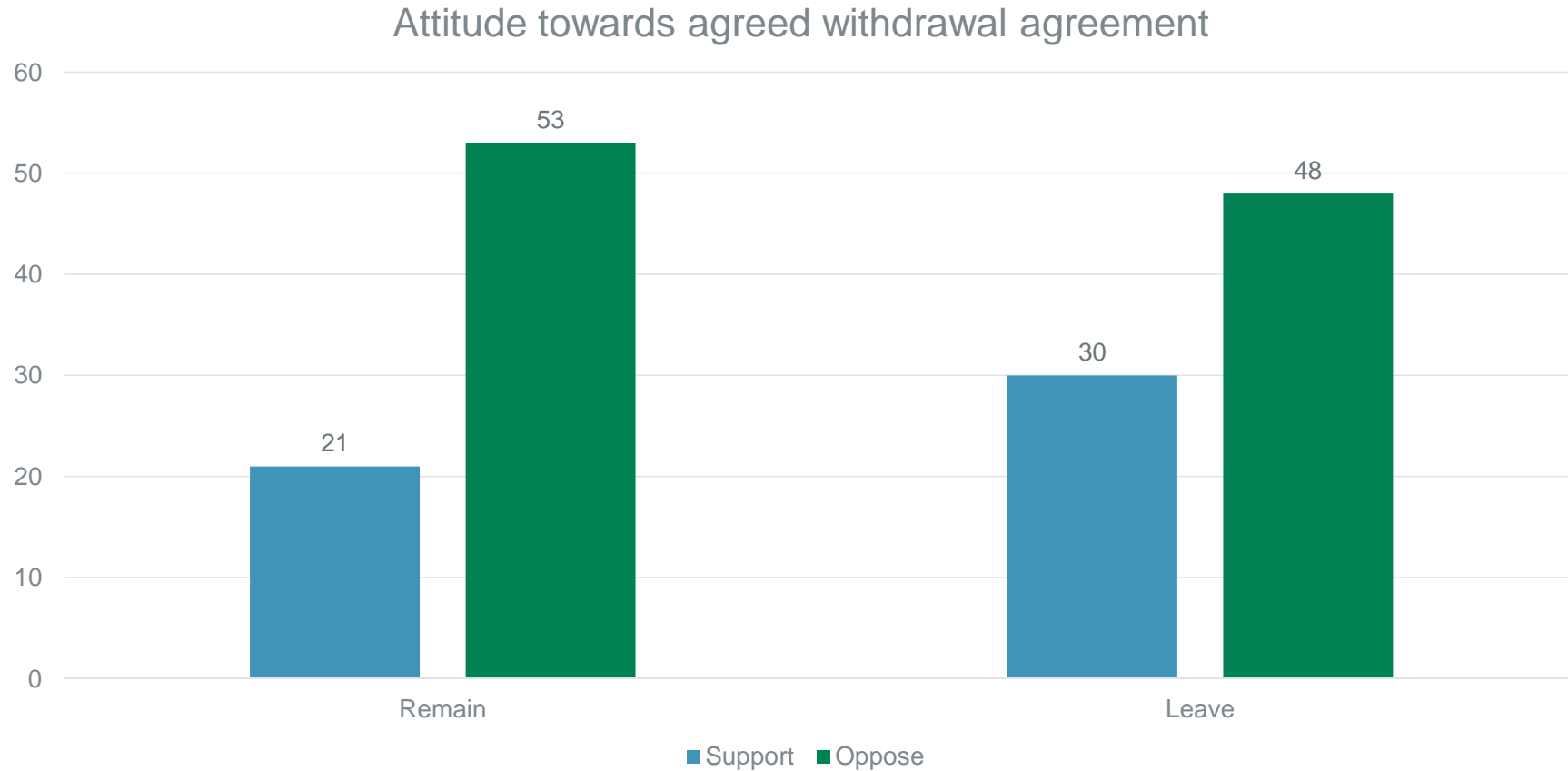

Challenges and Opportunities

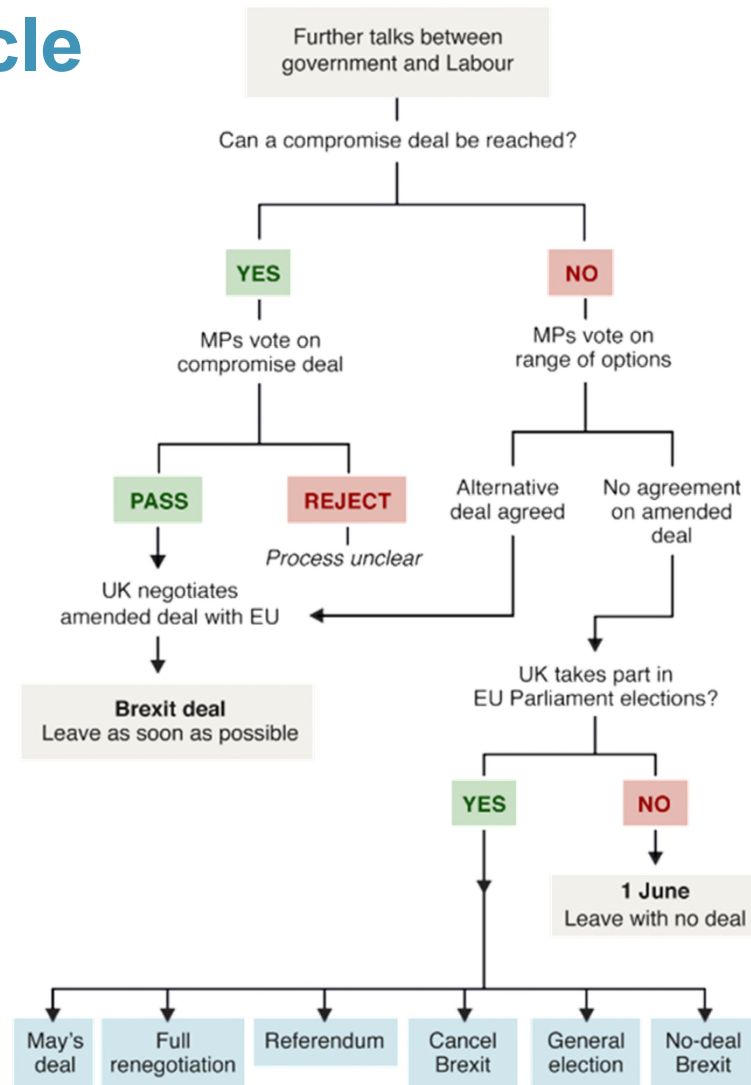
Positives Brexit provides

- The UK may still get a good deal
- There is scope for trade deals with a wider range of countries
- The UK public is engaged with politics more now than for a long time
- Democratic means may be used to break political deadlock – this whole process has been an exercise in democracy above all
- Brexit Britain may flourish on its own

Problems still remaining

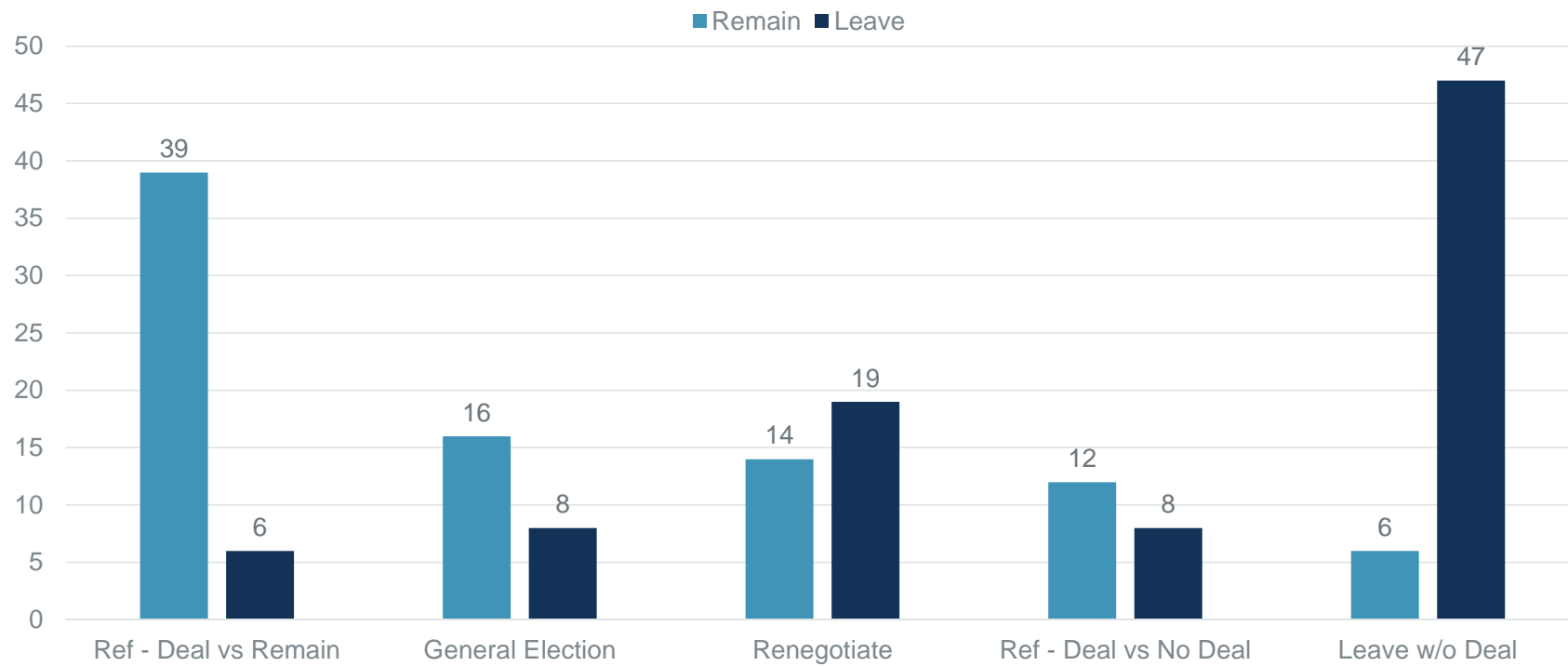
- Government unable to pass Withdrawal Act
- No clear majority for any other options
- Public opinion deeply divided
- Other domestic policy challenges ignored in favour of Brexit
- UK prevented by Parliament from leaving without a deal
- Clock is still ticking!
